


On February 17th the Commission attended an extravaganza activity hosted by the Enid Capron Primary School located in Five Cays of Providenciales. At the event the Commission provided informational leaflets on the Rights Of the Child Convention to grade groups ranging from four through five. The Commission also conducted a short educational session to the Grade six students who participated well by asking and answering questions.

On January 20th, the Turks and Caicos Islands Human Rights Commission's team conducted an open house exercise on Grand Turk. The purpose of the exercise was to enhance access to the commission in the outer islands and to offer residents the chance to obtain information about the commission's work, lodge complaints, and seek advice. The event was deemed a success.

The centre will be visited by the Commission again during the second quarter of the new financial period (2024–25).



The TCIHRC makes routine facility visits on a quarterly basis.
